



In June of 2011 Chief Dennis Dorsey was installed as chairman of the Georgia State Intelligence Network. The City of Winder Police Department has been a member of GSIN since the late 1980's and Chief Dorsey is the first officer from Winder to be nominated and elected to the Board of Directors in June of 2008

GSIN is a network of City, County, State, and Federal law enforcement who meet monthly to share information regarding criminal activities in their respective areas and exchange intelligence infor-

mation on crimes that are likely to occur in other areas of the State. GSIN offers training at each meeting and hosts two law enforcement training conferences annually.

GSIN was established in 1971 to assist agencies state wide with the collection, evaluation, preservation and dissemination of intelligence information concerning major and organized criminal activity in the State of Georgia. Members possess a common and continuing goal of developing information resulting in the apprehension of persons engaged in such criminal activities.

Officer Brent Davis received an award from Mothers Against Drunk Driving (MADD) for his arrests of persons suspected to be driving under the influence. Officer Davis received a Silver Pin Award and also under his guidance he led the Department to second place in the State of Georgia, for the Governor's Challenge award sponsored by the Governors Office of Highway Safety.

Along with the DUI enforcement he also conducts DUI education programs at the schools and keeps all records for the GOHS grant for the Department.



Officer Brent Davis made 42 Driving Under the Influence arrests from January 1, 2011 through December 31, 2011. He received the M.A.D.D. Silver Award. Officer Davis is currently assigned to the City of Winder's Traffic Enforcement Unit as the H.E.A.T. Officer.

In 2011 The City of Winder partnered with the Special Olympics of Georgia for third year in a row to participate in the 2011 Law Enforcement Torch Run. 

On July 7, 2011 the Winder Police Department assisted the Auburn Police Department with Taser Training. The Auburn Police Department asked for our assistance on the training of their Officers because they do not have a certified instructor on the Taser X26.

Lt. Rob Curott of the Winder Police Department is a Taser Certified Instructor. Lt. Curott conducted the class in the training room of the Winder Police Department for the Auburn Police Officers. During the training Officers learned the proper handling and use of the Taser device as well as proper handling of the spent probes to be used as further evidence and as a bio hazard. Officers also learned the science behind the Electronic Control Device, probe removal and first aid for the area affected as well as firing of the device.

Officers at the Winder Police Department go through annual refresher training to continue carrying the device as well.

Patrol Division





Lieutenant Rob Curott, a 17 year veteran of the Winder Police Department oversees the Patrol Division.

21 Officers are assigned to this Division.

In addition to Patrol Commander, Lieutenant Curott also serves as the interim Operations Commander, which is second in command of the Department.

The Patrol Division is the agency's first responders, and it is made up of four shifts. Each shift is commanded by a Sergeant and a Senior Patrol Officer, with a maximum strength of 5 Officers. Each shift has Officers designated as early units in order to insure continuous service during shift changes.

Officers of the Patrol Division are divided into zones in order to cover 14 square miles of the City. Current manpower assigned to Patrol is 23 members which include 2 recruit Officers who are in different stages of the field training program.

In order to effectively respond to a wide variety of calls, each Patrol Officer is trained in domestic violence, crime scene preservation, traffic enforcement, and accident investigation



Criminal Investigations/Support Services Division





Lieutenant John Blocker, an 18 year veteran of the Winder Police Department oversees the Criminal Investigative Division.

10 Sworn Officers, and 5.5 non-sworn employees are assigned to this division.

The Criminal Investigative Division is commanded by a Lieutenant and a Senior Investigator. The General Investigations Division is comprised of 9 investigators each with an expertise in a specific field. General Investigators maintain a twenty-four hour availability status by rotating an on-call schedule for investigations. Investigators conduct follow-up investigations on incidents reported to the Department. Types of investigations may range from Theft by Taking to Murder.

The Criminal Investigative Division also has an investigator assigned as a crime scene investigator. The Crime Scene Investigator is responsible for processing crime scenes, collecting evidence, and control and storage of property evidence.

The Office of Professional Standards is comprised of one Investigator that conducts internal affairs investigations, pre-employment background checks, and serves as the Department's Public Information Officer.

Support Services includes Communication Officers that work to support all Divisions within the Department.

Criminal Investigations



Major Case Investigation

On July 27, 2011 Officers of the Winder Police Department were asked to conduct a welfare check of a person who did not show up for work as scheduled, this being an unusual occurrence. Contact was not made at the residence of the individual. Family members received text messages from the person asking them to look after her children and that she was leaving her husband. Later in the day the person's vehicle was located by a family member in a parking lot, unattended.

Contact was made with the person's husband who agreed to meet with Officers at their residence. A walk through of the residence was conducted finding nothing out of the ordinary or anything that would suggest foul play. Interviews were conducted with several family members who voiced their concerns of the person's whereabouts, stating she would not go without having contact with her children, ranging in ages 7-15. It became known there was domestic violence history between her and her husband.

As the day turned into night it was decided to list the individual as a Missing Adult. The Winder Police Department's Criminal Investigations Division, along with, Officers of the Uniform Patrol Division, Crime Suppression Unit, Barrow County Sheriff's Office, and with the assistance of the Georgia Bureau of Investigations, conducted an extensive search for the missing person. Search warrants were executed on several properties.

In the next several days numerous interviews were continuously being conducted and all leads were being followed. Law Enforcement Officials worked endlessly and two days later on July 29, 2011 the missing person's body was located, bound, in a well. The individual's husband was criminally charged with Murder and is currently awaiting trial. The couple's four children are being raised by their Aunt and Uncle.



Communications personnel logged over 16,500 requests for police services in 2011, including 445 motor vehicle accidents and over 6100 traffic stops. In addition they also handled the following:



Lieutenant Henry Schotter, a 13 year veteran of the Winder Police Department oversees the Special Operations Division.

10 Sworn Officers are assigned to this Division

The Special Operations Division is commanded by a Lieutenant. The Division is comprised of 10 Officers each with an expertise in a specific field. They include Traffic Enforcement, Crime Suppression, Code Enforcement, School Resource Officers, and assigned members of the Barrow County Crime Task Force.

The Department's grant funded Traffic Unit or H.E.A.T. Unit is assigned to aggressive traffic that leads to accidents and injuries.

The Crime Suppression Unit was designed to target needed areas of concern with saturated patrol tactics.

The Code Enforcement Officer works with other City Departments to enforce quality of life issues.

School Resource Officers are assigned to each of the three schools located within the City Limits. They work as a liaison between the City of Winder Police Department and the Barrow County School System.

Special Operations



CRIME SUPPRESSION UNIT

The Crime Suppression Unit for the City of Winder was formed in April of 2011. The Unit consists of two highly motivated Officers that have and will continue to receive in-depth specialized training. This Unit will concentrate on specific areas within the City that are in need of specialized enforcement strategies and techniques.

The Crime Suppression Unit will utilize marked patrol cars, unmarked patrol cars and foot patrol. They are able to spend more time on each situation as they are not responsible for dispatched calls. They strictly handle complaints from the citizens, other members of the police department, and self-initiated activities aimed at lowering the crime rate and making Winder a safer community in which to live.

The School Resource Officer (SRO) program was implemented as part of the Winder Police Department's focus on better serving the City through community oriented policing. An SRO fills many different roles within his or her school:

- 1. An SRO is a vital member of the school's administrative team, helping to solve problems within the school community.
- 2. An SRO provides students with a positive role model, and a balanced view of law enforcement.
- 3. An SRO is a proactive law enforcement officer dealing with law related issues on campus.

Any criminal or law related issue that arises on campus is the SRO's responsibility. Whether it is child abuse, truancy, disorderly conduct, theft, or some type of assault, the SRO is there to handle it quickly and professionally. SRO's work closely with school administration.
